Protect Yourself Against Scams

At PASR, we like to remind our members to be mindful of who They giving information to and protect themselves against scams. Seniors can often be targeted because they tend to be trusting, polite, have financial savings, own a home, and have good credit. They also tend to be less inclined to report fraud because they don't know how to. Scammers use emails, texts, and phone calls to trick you into giving them your personal information. They are consistently changing ways to receive this information. However, knowing what to look for can potentially save you from being a victim of a scam. What signs to look for:

- Scammers will pretend to be from an organization you know, such as the IRS, Medicare, or the Social Security Administration.
- There's a problem or a prize involved. The scammer might say you owe money, you or a loved one is in trouble, or a virus is on your computer. They might tell you that you won money or a trip but need to do something or pay a fee before you can receive it.
- Scammers will pressure you to

do whatever they're asking IMMEDIATELY. They might tell you that you must act immediately, not giving you a chance to check out their story.

The person will tell you specific ways to pay, such as gift cards or sending money through a transfer company. What you can do to avoid scams:

- Block unwanted calls and text messages. You can also filter emails by placing them into a junk or spam folder.
- Do not give your information if they're asking for it. A legitimate company won't ask you for information, like your bank account or Social Security number.
- Do not act immediately. A legitimate business will give you time to decide.
- Search the company name or offer. People often post information about business scams online.
 Never give or send money by gift card, a money transfer service, jewelry, or wire information.

• Talk to someone you trust first. If you're unsure if it could be a scam, talk to a friend, family member, or neighbor. Talking about it could help you realize it's a scam. You can report fraud attempts at https://reportfraud.ftc.gov/#/.

If you believe you or someone you know has been a victim of fraud, you can contact your local FBI field office or submit a tip online at http:// tips.fbi.gov/. When reporting a scam, it is best to provide as much information as possible.

- Names of the scammer and company
- Dates of contact and the methods of communication
- Phone numbers, mailing addresses or email addresses
- Information of the methods of payment and if/where you sent funds
- Descriptions of your interactions, such as instructions given to you

COLA Update

Some Reasons to Pass a CO-LA Now

1.It has been far too long since the last COLA.

2. Since the passage of Act 9 of 2001, PSERS retirees have lost at least 1/3 of the value of their pensions due to inflation.

3. Inflation (Cost of Living) has increased over 73% since 1990.

4. About one-third (34.3%) of all PSERS annuitants have a pension of under \$10,000 per year.

5. Almost one-half (47.7%) of all PSERS annuitants have a pension of under \$20,000 per year.

6. Only 4.3% of all PSERS annuitants retired prior to 1990. It is a total of 9,638 people.

7. All annuitants who retired prior to 1986 have a yearly pension below \$7,623.

The Case for Pre-Act 9 Emphasis

The case for passing a COLA to help those who retired before the passage of Act 9 of 2001 is overwhelming. It is especially urgent for those who retired before 1990. Pre-Act 9 (those who retired prior to July 1, 2001) annuitants/retirees prior comprise only 20.9% of all retirees collecting a pension from PSERS. That is 47,435 out of 226,683 total annuitants. The Post-Act 9 annuitants outnumber the Pre-Act 9 annuitants 4.78 to 1. The data is complete as of July 1, 2021. In comparison, that number was 21.8% of the total with data complete as of January 1, 2021

Message from Our Acting Treasurer


Greetings from Home,
